(d) Details of Debit Card/Credit Card/UPI/Net banking for making fee payment (if applicable)  (e) Scanned Copy of Recent Photograph (not more than 3 weeks old in jpg/jpeg format). Size (50kb).  (f) Scanned Copy of Signature with Black ink pen (in jpg/jpeg format). Size (50kb).  (g) Scanned Copies of following documents (in pdf format):  i. Documentary proof of Date of Birth (Matriculation/10th/12th/HSC Certificate).  ii. Final/Provisional Degree/ Diploma/Graduation, etc., as applicable.  iii. Experience Certificates / documents in support of experience, if applicable.  iv. PWD Certificate [in case of Persons with Benchmark Disability (PwD) candidates].  v. Caste Certificate in respect of reserved categories in the prescribed format in respect of SC/ST and OBC Non-Creamy Layer.  vi. Income and asset certificate in respect of EWS in prescribed format  vii. Declaration of Non-Creamy Layer Status in respect of OBC (NCL) candidates in prescribed format.

6.	What if I do not have an email Id?	It is mandatory to have a valid e-mail id since all the future communication with the candidate shall be through e-mail.
