



GENERAL CONDITIONS AND INSTRUCTIONS

- (a) Only Indian nationals need to apply. Mere submission of application will not entail right for claiming Appointment.
- (b) The cut-off date for computing age and work experience is 31.03.2021
- (c) The registered candidates will have to undergo multiple choice type written test as per structure given below:
 - 1. Test Duration: 90 minutes
 - 2. Total Number of questions: 100
 - Section 1: General Aptitude (25 questions)
 - Section 2: General Knowledge (25 questions)
 - Section 3: Skill eco-system/domain knowledge (50 questions)
 - 3. No Negative Marking
- (d) The written test will be conducted as Computer Based Test at New Delhi, Kolkata, Chennai and Mumbai
- (e) Candidates are advised to ensure while applying that they fulfil the eligibility criteria and other requirements mentioned and that the particulars furnished by them are correct in all respects. Their candidature at every stage is purely provisional. In case it is detected at any stage of recruitment process that the candidate does not fulfil the eligibility criteria and/or does not comply with other requirements of this advertisement and /or he/she has furnished any incorrect or false information or has suppressed any material fact, his/her candidature is liable to be rejected.
